## Information on use

### General



<b>Location</b>	CAB Building Universitätstrasse 6 8092 Zurich
<b>Size</b>	Approx. 500 m <sup>2</sup> each
<b>Reservation</b>	The Kiesplätze (gravel areas) are managed by the Facility Services department. Please submit reservation enquiries to this email address: <a href="mailto:fs_gmz_un_isc@ethz.ch">fs_gmz_un_isc@ethz.ch</a>
<b>Permits</b>	Events and activities require permits. Enquiries about permits must be addressed to <a href="mailto:bewilligungen@services.ethz.ch">bewilligungen@services.ethz.ch</a> two weeks in advance.

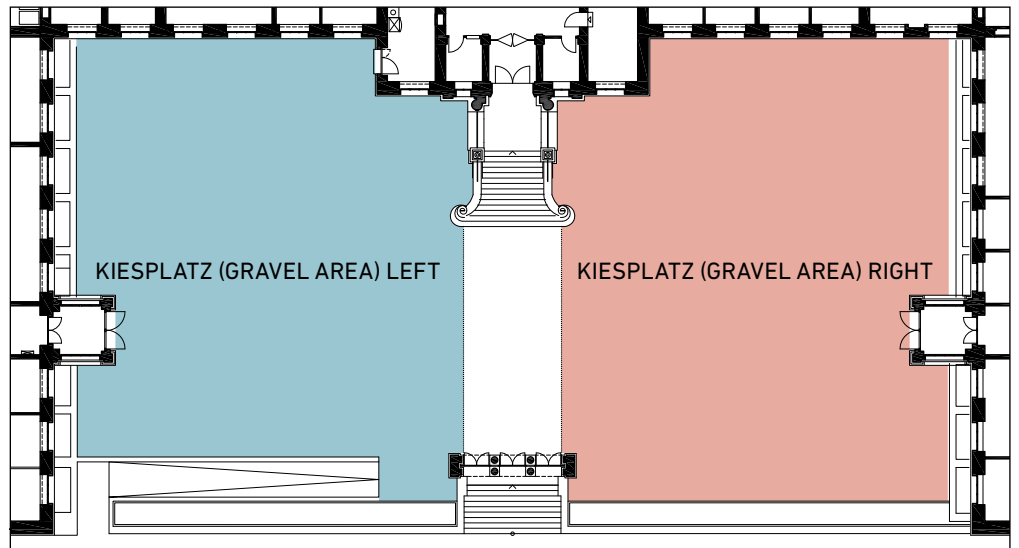
## Conditions for use

<b>Permitted use</b>	The left-hand Kiesplatz (gravel area) near the ETH Student Association (VSETH) is provided for students' activities. The right-hand Kiesplatz (gravel area) is for Department of Computer Science (D-INFK) activities, as shown on the plan. Barbecue events and small parties with low noise levels are permitted. (Large-scale) events with a higher noise level require agreement from the user of the other gravel area, i.e. D-INFK or VSETH.
<b>Smoking regulations</b>	Smokers are requested to maintain a minimum distance of 7.5 m from the building so that workplaces are not adversely affected by passive smoking.
<b>Authorised persons</b>	These areas are primarily authorised for use by members of D-INFK and VSETH. Both units are notified about upcoming events as quickly as possible via the Permits Office.
<b>Furniture</b>	The Facility Services department cannot provide any furniture for the outdoor areas. Furniture must be sourced by the event organiser and may only be set up if deliveries are not affected.
<b>Barbecue</b>	The barbecue must be positioned so that the smoke can dissipate. A minimum distance of 5 m from the building must be maintained. Suitable extinguishing equipment must be provided. The responsible persons on site must be instructed on the handling of the extinguishing agents.
<b>Ramp</b>	The ramp leading to the left-hand Kiesplatz (gravel area) must remain clear at all times.
<b>Tents and structures</b>	Tents and other structures must be secured against wind.
<b>Fire regulations</b>	Compliance with the fire regulations is required. Escape routes and fire brigade access routes (ramp escape routes) must be kept clear at all times. No building exits or stairs must be blocked. Locations for exhibits must be agreed in advance with the Facility Services department.
<b>Waste disposal, cleaning</b>	The areas must be left in a clean condition. The event organiser is responsible for disposing of waste in the appropriate containers (bottles, cans and glass). If there are large quantities of waste, the Facility Services department must be called in. Expenses for cleaning and services that exceed the usual scope will be invoiced as per the price list. Suitable covers must be fitted for activities that could contaminate or damage the ground.
<b>Noise emissions, music</b>	Consideration must be shown for the users of the CAB Building and the neighbours. Unless explicitly approved, it is only permitted to play music (including background music) – approx. 70 dB – after 5 p.m. In all cases, silence must be maintained in the outdoor area at night, from 10 p.m. onwards.
